The U.S. Army Corps of Engineers, Central Valley Flood Protection Board, and Sacramento Area Flood Control Agency propose to construct levee improvements consisting of approximately 3,000 linear feet of bank protection and on-site riparian habitat features to address erosion concern at Site 1-1 along the left bank (when facing downstream) of the Lower American River near Interstate Business 80. Most of the levee improvements included in the Project were analyzed in the American River Common Features General Reevaluation Report (ARCF GRR) Environmental Impact Statement/Environmental Impact Report (EIS/EIR, SCH #2005072046). This Draft Supplemental EIR addresses project modifications and refinements since publication of the ARCF GRR EIS/EIR.
