Project Title: Pure Water Oceanside (Streambed Alteration Agreement for horizontal directional drilling beneath the San Luis Rey River)

Project Applicant: City of Oceanside

Project Location (include county): The project is located beneath and potentially within the bed, channel, and bank of the San Luis Rey River paralleling Douglas Drive, along the western shoulder and the eastern shoulder, in the City of Oceanside, County of San Diego.

Project Description: CDFW is intending to execute a Streambed Alteration Agreement pursuant to Section 1602 of the Fish and Game Code (# 1600-2020-0033-R5) to the project applicant, City of Oceanside. The project proposes the installation of two pipelines beneath the San Luis Rey River via horizontal directional drilling and, if necessary, the remediation of any drilling-related problems that may be encountered.
