Project Title: Addendum No. 1 to the LB-MUST Project (NDA 01-21) (Mitigated Negative Declaration (ND 03-17) for the Long Beach Municipal Urban Stormwater Treatment (MUST) Project)

Project Description: Modification to a previously approved Long Beach Municipal Stormwater Treatment (LB-MUST) Project (App. No 1807-12) to relocate the proposed wetlands to a 1.23-acre site across the street from the LB-MUST Treatment Facility at 901 De Forest Avenue. The scope of work includes installation of a 4-inch forcemain from existing pump station SD-02 to the LB-MUST Treatment Facility and to the new wetland location, which is not subject to Site Plan Review (SPR) but is included in the environmental analysis prepared for this project scope.

Environmental Review: Pursuant to Section 15164 of the CEQA Guidelines, this project is covered by the adopted Mitigated Negative Declaration (ND 03-17) for the LB-MUST Project (SCH No. 2017071068) and an Addendum was prepared for the project description changes (EIRA 01-21). The Addendum found that the project will have no new potentially significant impacts upon the environment that were not analyzed by the LB-MUST Project IS/MND.

Project Applicant

Project Location: Regionally, the project site is located within the southwestern portion of the City of Long Beach, Los Angeles County, California. Locally, the project site is situated along the east and west sides of the Los Angeles (LA) River, and generally extends a distance of approximately 8 miles from State Route 91 (SR-91) to the north to approximately 0.1-mile south of Ocean Boulevard to the south.

Project Description: The City of Long Beach is situated at the confluence of the LA River. Currently, substantial quantities of pollutants (metals, bacteria, hydrocarbons, pesticides, and trash) enter the LA River via urban runoff and accumulate in the Long Beach Harbor. Runoff includes water draining from urban uses such as streets, parking lots, driveways, and lawns that flow through the storm drain system. The Long Beach MUST Project would divert and convey dry-weather and "first-flush" storm flows to the treatment facility prior to discharge into the LA River, resulting in water quality benefits in the project area.
