Project Description: The California Department of Toxic Substances Control (DTSC) adopted an Addendum to the previous Initial Study/Negative Declaration (IS/ND) and approved the renewal of an existing Hazardous Waste Facility Post-Closure Permit (PCP), pursuant to authority granted under California Health and Safety Code Chapter 6.5 and California Code of Regulations, Title 22, Division 4.5, Chapter 20.

The current post-closure operations regulated by DTSC at the Facility includes groundwater monitoring, and remediation for the entire facility pursuant to requirements of the RWQCB, SCR Order No. R2-2007-0005. Honeywell does not conduct any manufacturing, hazardous waste generation or handling or participate in any other activities regulated by DTSC. The permit renewal will not result in any physical changes, nor any changes in the day-to-day operations of the facility. This permit modification would not affect any aspect of the environment and requires no construction. All post closure activities will continue to be consistent with the previously approved Post Closure Permit. The renewal of an existing Hazardous Waste Facility PCP would not result in a significant impact on the environment.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on October 23, 2020 and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. A Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were not made a condition of project approval.
4. A Statement of Overriding Considerations was not adopted for this project.
5. Findings were not made pursuant to the provisions of CEQA.
