Project Title: Camellia Farms, LLC (Lake or Streambed Alteration Agreement No. EPIMS-TRI-34460-R1)

Project Location (Trinity): The Project is located at Lamb Creek a tributary to Mad River, in Trinity County Trinity, California; Latitude 40.453132, Longitude -123.502641; Section 21, Township 01N, Range 06E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey (USGS) 7.5-minute quadrangle; Assessor's Parcel Number 018-630-11-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-TRI-34460-R1), pursuant to Fish and Game Code section 1602, to the project Applicant, **Florence St-Onge**

The Project is limited to water diversion at one encroachment, maintenance of the diversion structure, and development of a rain catchment reservoir for water storage.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on June 1, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
