Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 016-250-004-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-661) and has applied for Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; LCA24-0000204). Cultivation activities include approx. 10,000sqft of mature canopy in four (4) 30'x 96' permanent greenhouses. Immature canopy will be grown in the same greenhouses and then transitioned to mature canopy. Existing support infrastructure includes six (6) 3,000-gallon water tanks (located on this parcel, 016-250-004-000, shared with CCL-660), a 40'x40' compost area (located on 016-250-009-000, shared with CCL-660), and two (2) 8'x40' containers for general equipment storage (located on 016-250-009-000, shared with CCL-660. Water for the project would be provided from a well located on APN: 016-250-004-000 and shared with CCL-660 the adjoining property 016-250-009-000. A permitted septic system located on APN: 016-250-004-000 and shared with adjoining project, same property owner, CCL-660 that services the projects' wastewater needs. Power is provided by TPUD. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
