Project Location (Trinity): The Project is located on an unnamed tributary to Duncan Creek in Trinity County, CA; T31N, R11W, Section 1, Mt. Diablo Base and Meridian, U.S. Geological Survey (USGS) Hayfork Summit quadrangle, County Assessor's Parcel Number 017-010-69-00, 351 Duncan Creek Lane, Hayfork.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-TRI-17560-R1) pursuant to Fish and Game Code section 1602, to the project Applicant, **Dimitar Dimitrov**.

The project is limited to four Projects, 1) the removal of an existing seep well diversion on an intermittent stream, 2) use of an existing seep well diversion on an intermittent stream for fire suppression, 3) installation of an overflow spillway structure on an existing impoundment of an intermittent stream, and 4) the replacement of one existing culvert located on an ephemeral stream.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on June 7, 2024, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
