Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 020-080-011-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-130) and currently holds a Medicinal Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL20-0001175, Expires on 2024-11-06). Cultivation activities include approx. 10,000sqft of mature canopy in ten (10) 10'x100' hoop houses; immature canopy is within four (4) 24'x100' hoop houses. Existing support infrastructure includes an onsite permitted groundwater well, two (2) 5,000-gallon and two (2) 1,500-gallon water storage tanks, 15'x15' compost area. Power for the project is provided by diesel and gas generators including the proposed purchase of carbon offsets. A permitted onsite septic system will serve the project's wastewater needs. Proposed activities include the installation of an 8'x20' shipping container and 30'x60' barn for processing, harvest and ag chemical storage on previously disturbed area. A more detailed project description can be found in the Appendix C Checklist. SPECIAL NOTES: 1. The Site Plan and permit application for BLDG2024-00085 include a 20'x100' hoop house however the Project Description details the same structure as a 24'x100' hoop house.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
