Project Location (Trinity): The project is located on an unnamed tributary to Road Gulch Creek in Trinity County, CA; T30N, R12W, section 34, Mt. Diablo Base and Meridian, Dubakella Mountain U.S. Geological Survey (USGS) quadrangle, County Assessor's Parcel Number 019-390-03-00, 300 Trinity Pines Drive, Hayfork.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (1600-2020-0056-R1), pursuant to Fish and Game Code section 1602, to the project Applicant, **Lindsey Lee**.

The project consists of the maintenance and placement of erosion protection for one single-culvert stream conveyance and the armoring of one ford-style crossing on an unnamed ephemeral tributary to Road Gulch Creek.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on July 31, 2024, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
