Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 024-070-019-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-805) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; LCA24-0000265). Cultivation activities will include approx. 8,450sqft of mature canopy in thirty (30) existing 4.5'x4.5' boxes, (170) proposed 4.5'x4.5' boxes for mature canopy; and a proposed 6'x100' hoop house for immature canopy. Existing support infrastructure includes a 24.5'x37' barn for general storage and petroleum storage. The project proposes to install five (5) 10'x12' sheds for post-harvest storage, agricultural chemical and pesticide storage, packaging, and immature canopy; installation of two (2) 10'x12' cannabis waste area for composting; and installation of a 2,500-gallon water storage tank. Project development will not require any vegetation removal; the proposed cultivation boxes will be placed around existing trees, and all leveling will be performed with hand tools. Water for the project will be supplied by a permitted onsite groundwater well; a permitted onsite septic will serve the project's wastewater needs; and energy for the project is supplied by Trinity PUD. A more detailed project description can be found in the Appendix C Checklist.
