Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light cannabis located in Trinity County on Assessor's Parcel Number (APN): 015-420-028-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-761) and currently holds an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL23-0000281, Expires on 2024-11-07). Cultivation activities include approx. 10,000 SF of mixed-light cultivation canopy in four (4) greenhouses 25'x100'. The four (4) 25'x100' greenhouses are also used for immature and then transitioned into mature canopy. Existing infrastructure includes two (2) groundwater wells, three (3) 8'x40' (320 SF) shipping containers, three (3) 10'x10' (100 SF) sheds, 10'x20' (200 SF) compost area, two (2) 1,100-gallon and four (4) 2,500 gallon water storage tanks. Proposed activities include the installation of (38) additional 5,000 gallon water storage tanks and relocation of any project elements west of the property boundary into an additional fourth 8'x40' shipping container, previously disturbed area otherwise to be removed and remediated as appropriate. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103).
