Project Description: The proposed cultivation project described herein (Project) is the continuation of existing cultivation activities located in Trinity County on Assessor's Parcel Number (APN) 025-140-023 & 025-140-027. The applicant is applying for a cannabis cultivation license from the Trinity County Planning Department (CCL-228) to cultivate up to 10,000 square feet (sqft) of mature Outdoor canopy. The existing cultivation currently includes a 6' x 80' bed, fourteen (14) 7' x 7' boxes, two (2) 8' x 8' boxes, and (220) 6' x 6' boxes for mature canopy; and a 8' x 10' box, a 10' x 12, and two (2) 6' x 16' for immature canopy. Other supporting structures include: a 22'x24' building containing a 6'x21' processing area, a 16'x24' processing area, and a 2'x3' administrative holding area; a 16'x20' harvest storage building; a 10'x12' agricultural chemical/pesticide storage shed; a 10'x12' cannabis waste composting area; six (6) 2,500-gallon water storage tanks and a 2,100-gallon water storage tank; and five (5) 275-gallon nutrient mixing tanks. Onsite septic system will serve the project's wastewater needs, energy will be provided through an electrical grid through Trinity Public Utility District (TPUD), and water will be provided through a permitted groundwater well.

SPECIAL NOTE: Applicant has provided supplemental Odor Control Plan to fall in compliance with: Resolution NO. 2023-071, "A resolution of the Board of Supervisors of The County of Trinity allowing streamlined approval of cannabis licenses that require CCV's or the calender year 2023".

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
