Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light located in Trinity County on Assessor's Parcel Number (APN): 017-430-033. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-482) and holds an Adult-Use Small Mixed-Light Tier 2 Cannabis Cultivation License from the Department of Cannabis Control (CCL20-0001368, Expires on 2024-03-05). Cultivation activities include four (4) 30'x96' permitted permanent greenhouses consisting of four (4) 6'x83.3' rows each for a total of approx. 7,996.8 sqft mature cultivation. Existing support infrastructure includes a 30'x96' immature canopy area, Municipal Water through Trinity County Waterworks, three (3) 2,500-gallon and a 1,500-gallon water storage tank, a 500-gallon nutrient mixing tank, a 20'x40' support building for agricultural chemical/pesticide storage, immature canopy area, and a second immature canopy area that will be repurposed for processing, a 600 sqft cannabis waste area (20'x30'), two (2) 8'x40' sheds and a 20'x22' building for processing and admin hold which will be repurposed as harvest storage, and a 6'x30' area for agricultural chemical/pesticide storage. Power is provided through the TPUD grid. A more detailed project description can be found in the Appendix C Checklist. SPECIAL NOTE: Applicant has provided supplemental Odor, Noise, and Light Attenuation Plan to fall in compliance with: Resolution NO. 2023-071, "A Resolution of the Board of Supervisors of The County of Trinity allowing streamlined approval of cannabis licenses that require CCVs for the calendar year 2023".

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")( SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
