Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of Mixed Light Commercial Cannabis located in Trinity County on Assessor's Parcel Number (APN): 018-050-067-000. The applicant is seeking a Small Mixed-Light Cultivation License from the County (CCL-739) and currently holds a Provisional Adult-Use - Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL22-0001402, Expires on 2023-09-30). Cultivation activities include approx. 9,688 SF of mature canopy area that includes six (6) 6'x100', three (3) 6'x84', two (2) 6'x95', a 6'x70', a 6'x86', a 6'x80', a 6'x40', a 6'x30', and a 20'x80' hoop-house for mature canopy. Existing support infrastructure includes a 10'x10' cannabis waste area for composting; an 8'x40' metal container with an 8'x20' processing area and 8'x20' harvest storage area; a 8'x40' metal container with a 4'x40' packaging area and 4'x40' agricultural chemical and nutrient storage area; a 10'x12' shed for administrative hold; one (1) 2,500-gallon water storage tank; one (1) 3,000-gallon agricultural chemical mixing tank; and a ground water well used for domestic and agricultural needs. Proposed infrastructure includes installation of two (2) 30'x100' hoop-houses for immature plant canopy and removal of an unused 18'x23' structure. Power for the Project site is provided through an existing connection to Pacific Gas and Electric grid. A more detailed project description can be found in the Appendix C Checklist

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR. No further environmental review is required because the County finds, based on substantial evidence in the Record of Proceedings, that approval of this project is a "later activity" associated with the Cannabis Program EIR, as defined by subsection (c) of Section 15168, in that (i)all impacts associated with the approval of this project are within the scope of environmental review previously studied, and (ii) the requirements and mitigations required by Chapter 17.43 and 17.43G of the Trinity County Code, adequately serve to mitigate the impacts associated with approval of this project.
