Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 5,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 024-300-009-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-094) and currently holds an Adult-Use Specialty Mixed-Light Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0003640, Expires on 2024-08-10). Cultivation activities include approx. 4,290sqft of mature canopy in twenty-one (21) hoop-houses for mature canopy (a 5'x40', four (4) 5'x42', a 5'x43', three (3) 5'x44', a 5'x45', six (6) 5'x48', two (2) 5'x53', and three (3) 5'x54'). Existing support infrastructure includes a permitted groundwater well for domestic and agricultural uses; a 1,400-gallon and three (3) 2,500-gallon water storage tanks; a 350-gallon and a 500-gallon nutrient mixing tanks, a 19.5'x23.5' building for processing and harvest storage (11.83'x19.5') also with immature plant cultivation area using shelves to maximize space (390.5 sf), and an agricultural chemical and pesticide storage and administrative hold area (7.67'x11.5'); two (2) additional areas for immature plant cultivation (18'x45' and 20.5'x46'); and a 10'x10' cannabis waste and composting area. There is no proposed development associated with the Project. A more detailed project description can be found in the Appendix C Checklist. MINOR MODIFICATION: 1. On February 5, 2024 the applicant submitted a minor modification request to change license type from specialty mixed light to specialty outdoor due to DCC regulation changes allowing light deprivation with outdoor license types; no other site

changes needed to match state license type.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
