Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light cannabis located in Trinity County on Assessor's Parcel Number (APN): 019-050-005. The applicant is seeking a Small Mixed-light Cannabis Cultivation License from the County (CCL-743) and a Small Mixed-light Cannabis Cultivation License from the Department of Cannabis Control. Cultivation activities include the proposed installation of eight (8) 6'x80' hoop houses and six (6) 6'x150' hoop houses for a total of approx. 9,240 SF of mixed-light cultivation area. Support infrastructure includes an existing 20'x20' shed for chemical storage, processing and harvest storage, a 12'x12' compost area and the addition of a 40'x20' open staging area for immature plants on a previously graded area. The proposed project includes the use of a groundwater well for water source, four (4) 2,500-gallon, one (1) 1,500-gallon, one (1) 3,500-gallon, and one (1) 1,000-gallon water storage tank. The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
