Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 016-160-079-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-714) and is also seeking an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL22-0001001, Expires on 2025-02-09). Proposed activities will include installation of six (6) permitted 30'x110' greenhouses for cultivation operations. The proposed structures will include approx. 9,900sqft of mature canopy, and 9,900sqft of immature canopy in three (3) greenhouses each, respectively. The project will also include: one (1) proposed 20'x60' steel building, one (1) existing barn (1,715sqft) for processing, immature and cannabis waste, (1) existing onsite groundwater well and pump, four (4) proposed 2,500-gallon water tanks, one (1) proposed 1,250-gallon water tank, and one (1) proposed 550-gallon water tank. Very minimal grading, clearing and construction will be needed to develop the proposed project areas. A more detailed project description can be found in the Appendix C document.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
