Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 024-680-004-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-522) and currently holds an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0002236, expires on 2024-11-18). Cultivation activities include approx. 9,930sqft of mature canopy in thirty-seven (37) hoop house rows for mature canopy of the following dimensions: twenty-five (25) 6'x50', a 6'x60', five (5) 6'x35', five (5) 6'x30', and a 6'x20'. Existing support infrastructure includes a 16'x18' shed for processing; an 8'x15' shed for harvest storage; an 8'x40' shipping container for processing; 10'x12' shed for agricultural chemical/pesticide storage, also housing a 2'x3' tote for administrative hold; 10'x12' cannabis waste composting area; a permitted well for domestic and agricultural use; a spring diversion for agricultural use; three (3) 250-gallon and fifteen (15) 2,500-gallon water storage tanks; and a 8'x22' (approximately 8,990 gallons) water storage tank. Power for the project is provided by TPUD and there is permitted septic system on-site. A more detailed project description can be found in the Appendix C Checklist.
