Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 024-010-044-000. The applicant is seeking a Small Mixed-Light Cannabis Cultivation License from the County (CCL-416) and is also seeking an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0001744, Expires on 2025-01-23) as well as proposed self-transportation (self-distributor) license with DCC. Cultivation activities include approx. 7,378sqft mature canopy composed of four (4) greenhouses (35'x35', two (2) 35'x100', and 35'x120'). Existing support infrastructure includes a permitted onsite groundwater well; a 750-gallon, five (5) 2,500-gallon, and two (2) 5,000-gallon water storage tanks; three (3) 275-gallon and two (2) 550-gallon nutrient mixing tanks; a 40'x50' building for immature canopy, a 25'x40' building for harvest storage and processing; and a 10'x20' compost waste area. There is a permitted onsite septic system that services the project's wastewater needs. Power for the project is provided by TPUD. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
