Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-390-016-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-831) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities will include approx. 6,119sqft mature canopy in (99) existing 5' diameter pots (with a 7' diameter canopy area each) and 60 additional proposed 5' diameter pots to be installed on previously disturbed area for mature canopy. Existing support infrastructure includes a 3,000-gallon water storage tank and a 250-gallon nutrient mixing tank. Proposed activities include minimal grading, vegetation removal for the installation of four (4) 10'x12' sheds for the following uses: petroleum storage, agricultural chemical and pesticide storage, and two (2) for harvest storage, a 14'x20' shed for processing, a 20'x20' composting area, two (2) 6'x50' hoop houses for immature canopy and a 500-gallon nutrient mixing tank. There is a permitted onsite septic system that services the project's wastewater needs. Power for the project is provided by generators under 50hp. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
