Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 5,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-610-030-000. The applicant is seeking a Specialty Outdoor Cannabis Cultivation License from the County (CCL-843) and is also seeking an Adult-Use Specialty Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities include (110) boxes for mature canopy (approximately 4'x4' with up to 36sf canopy each), an 8'x12' shed for processing/drying, a 10'x16' composting area, a 4'x4' shed for agricultural chemical and pesticide storage, two (2) 10'x 8' sheds for harvest storage, a permitted onsite groundwater well, two (2) 2,500-gallon, one (1) 1,000-gallon, and one (1) 500-gallon water storage tank used for both domestic and irrigation purposes. Power for the project is provide by generators less than 50hp, solar pump for well and there is a permitted onsite septic system to serve the project's wastewater needs. Proposed activities include the installation of an additional (28) boxes on previously disturbed area that will be approximately 4'x4' and have a mature canopy area not to exceed 36sf each for a total of approx. 4,968sqft mature canopy. A more detailed project description can be found in the Appendix C Checklist.
