Project Location (Trinity): This project is located at 151 Duncan Creek Lane, Hayfork, CA 96041; Assessor's Parcel Number 017-010-037-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-TRI-13041-R1), pursuant to Fish and Game Code section 1602, to the project Applicant, Milos Mirosavic.

The project is limited to two projects. Project 1 is the re-establishment of a stream channel back to its historic flow path, which will hydrologically disconnect the pond, making it off-channel. This work includes upgrading the spillway of the pond, so it will not overtop and connect to the stream. Project 2 is the installation of a new seep well and the diversion of subsurface water for irrigation purposes.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on December 4, 2023, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
- 3. Mitigation measures were made a condition of CDFW's approval of the project.
- 4. A Mitigation Reporting or Monitoring Plan was adopted by CDFW for this project.
- 5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
- 6. Findings were made by CDFW pursuant to California Code of Regulations section 15091.
