Project Title: TRINITY ROOTS ENTERPRISES, INC.

Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 024-690-011-000. The applicant currently holds a Small Outdoor Cannabis Cultivation License from the County (CCL-107) and also currently holds an Adult-Use Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0002016; Expires on 2025-04-15) as well as a proposed Self-Transport Distribution License with the DCC. Cultivation activities include a 30'x40' area and (75) 12' circular garden beds for mature canopy. Existing support infrastructure includes a 30'x30' area for immature canopy, a 15'x25' compost area for cannabis waste; a 12'x10' for general storage area; a 30'x48 shop for processing, harvest storage, immature plant area, and pesticide and agricultural chemical storage area; and a 2,600-gallon water storage tank for cultivation and domestic use. Proposed development activities include the installation of three (3) 2,600-gallon water storage tanks for cultivation use, and potentially transitioning the 30'x40' existing mature canopy area to a permitted greenhouse. Water for the project is provided by a permitted onsite groundwater well; a permitted onsite septic will serve as the project's waste water needs; the project is connected to an electrical grid provided by Trinity PUD with a backup generator. 

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR. No further environmental review is required because the County finds, based on substantial evidence in the Record of Proceedings, that approval of this project is a "later activity" associated with the Cannabis Program EIR, as defined by subsection (c) of Section 15168, in that (i) all impacts associated with the approval of this project are within the scope of environmental review previously studied, and (ii) the requirements and mitigations required by Chapter 17.43 and 17.43G of the Trinity County Code, adequately serve to mitigate the impacts associated with approval of this project.
