Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 017-450-009-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-768) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities include approx. 8,960.2sqft mature canopy in (43) seven-foot (7') diameter pots, one (1) 8'x82.6' bed, one (1) 8'x8' canopy area, four (4) 7'x92.8' beds, four (4) 7'x93' beds, one (1) 6'x89' hoop-house and (20) 6.5'x6.5' boxes. Existing support infrastructure includes a permitted onsite groundwater well, one (1) 1,500-gallon, one (1) 5,000-gallon and four (4) 2,500-gallon water storage tanks; two (2) 250-gallon nutrient mixing tanks; one (1) 6'x30' and one (1) 15.3'x29.7' hoop-house for immature canopy; a 4.2'x8.5' structure for petroleum storage; an 8'x20' metal container for processing that will become harvest storage and packaging; an 8.6'x9.75' shed for agricultural chemical and pesticide storage as well as a general compost area in that cannabis compost will be worked back into the soil within the mature canopy cultivation areas. There is a permitted onsite septic system that services the project's wastewater needs. Power for the project is provided by TPUD. A more detailed project description can be found in the Appendix C Checklist.

The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR") (SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
