Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 011-410-015-000. The applicant currently holds a Small Mixed-Light Cannabis Cultivation License from the County (CCL-710) and also currently holds an Adult-Use Small Mixed-Light Tier 1 Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL23-0000309, Expires: 2026-01-26). Cultivation activities will include approx. 6,000sqft mature canopy in two (2) proposed 30'x100' greenhouses and 6,000sqft immature canopy in two (2) proposed 30'x100' greenhouses. Other existing support infrastructure includes a 20'x25' building for harvest storage and processing; a 10'x15' composting area; a 20'x22' building for agricultural chemical/pesticide storage; and a 5,000-gallon water storage tank. Proposed structures will be installed in natural tree canopy openings and will not require any tree removal or grading. Water for the project is provided by a permitted onsite groundwater well; a permitted onsite septic will serve the project's wastewater needs; the project is connected to an electrical grid provided by Trinity PUD with a backup generator. A more detailed project description can be found in the Appendix C Checklist. SPECIAL NOTES: 1. The proposed greenhouses for mature canopy are being proposed in a location that was determined by county staff on inspection 3/10/2025 not to be a potential swale area otherwise county approved for development of that previously disturbed area, including no tree removal.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103).
