Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 019-050-005-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-743) and currently holds an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL23-0000531, Expires on 2026-03-22). Cultivation activities will include approx. 9,240sqft of mature canopy in eight (8) 6'x80' hoop houses, two (2) 6'x90', and six (6) 6'x120' hoop houses to be installed on previously disturbed areas. Existing support infrastructure includes a permitted onsite groundwater well, a 20'x20 shed for ag chemical, harvest storage and processing; there is a 12'x12' compost area and a 40'x20' open staging area for immature plants; four (4) 2,500-gallon, a 1,500-gallon, a 3,500-gallon, and a 1,000-gallon water storage tank. Proposed activities include the installation of a 30'x70' building for processing, ag chemical and harvest storage on a previously graded area. There is a permitted septic system onsite to serve the project's wastewater needs and power for the project is provide by TPUD. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
