Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 018-050-056-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-679) and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC). Cultivation activities are approved to include approx. 9,792sqft in a 35'x150' and 35'x120' greenhouses with three (3) 8'x112' beds each (2,688sqft mature canopy), a 35'x120' greenhouse with three (3) 8'x92' beds (2,208sqft mature canopy) and a 35'x116' greenhouse with three (3) 8'x92' (2,208sqft mature canopy). Support infrastructure will include a 10'x20' cannabis waste composting area, a permitted onsite groundwater well, a 32'x60' Barn for Propagation, Drying, Processing, Harvest Storage, an 8'x70' immature plant open staging area onsite and a 50'x100' (5,000sqft) immature plant open staging area located on adjoining parcel with the same owner, APN 018-050-048; there are two (2) 900-gallon, four (4) 2,500-gallon water storage tanks onsite as well as a 5,000-gallon, two (2) 2,500-gallon water storage tanks for fire suppression. Power for the project is provided by PG&E and there is a permitted septic system onsite to serve the project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
