Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of outdoor, with proposed transition to mixed-light mature canopy located in Trinity County on Assessor's Parcel Number (APN): 014-450-013-000. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-811), with proposed transition to Specialty Cottage Mixed-Light up to Small Mixed-Light from the County and is also seeking an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC), with proposed transition to Specialty Cottage Mixed-Light up to Small Mixed-Light from the DCC. Cultivation activities will include approx. 9,110sqft of mature canopy. Existing support infrastructure includes an 8'x40' container for processing, two (2) 10'x10' sheds for ag chemical storage, processing and immature canopy, a 52'x16' greenhouse for immature canopy, two (2) 6'x72' and ten (10) 6'x76' beds for mature canopy, five (5) 5'x70' beds for mature canopy within a 76'x30' greenhouse; a permitted onsite groundwater well, a 5,000-gallon and a 1,000-gallon water storage tank. Proposed activities include the installation of six (6) 6'x76' beds for mature canopy as well as two (2) 8'x20' containers for processing, 30'x30' compost area, a 2,500-gallon and 500-gallon water storage tank all on previously disturbed area. There is a permitted septic system onsite that services the project's wastewater needs and power for the project is provided by TPUD. A more detailed project description can be found in the Appendix C Checklist.



The County finds that the adoption of the proposed project falls within the Trinity County Cannabis Program Environmental Impact Report ("EIR")(SCH# 2018122049). Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
