Project Description: The proposed cultivation project described herein (Project) includes the cultivation of up to 10,000 square feet (SF) of mixed-light with proposed transition to outdoor mature canopy located in Trinity County on Assessor's Parcel Number (APN): 017-450-021-000. The applicant currently holds a Small Mixed-Light Cannabis Cultivation License from the County (CCL-212), with proposed transition to Small Outdoor from the County and currently holds an Adult-Use Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0000048, Expires on 2025-11-07). Cultivation activities include approx. 8,998.5sqft mature canopy in seventeen hoop houses (6'x72'8", 6'x86'4", 6'x90'8", seven (7) 6'x100', 6'x70'8", 6'x75', 6'x80'3", 6'x89'11", 6'x85', 6'x51'1", and 6'x98'2"). Existing support infrastructure includes a 21'x46' hoop house for immature canopy; a 60'x105'5" area for immature canopy; a 10'x12' shed for ag chemical storage; a 7'x9' shed for post-harvest processing and harvest storage; a 20'x20' cannabis waste and composting area, a permitted onsite groundwater well and two (2) 2,500-gallon water storage tanks. Power for the project is provided by TPUD. There is a permitted septic system located on the neighboring APN 017-450-020, shared with CCL-672, and same property owner, to serve the project's wastewater needs. A more detailed project description can be found in the Appendix C Checklist.

Certified by the Board of Supervisors on December 21, 2020 (Resolution 2020-103). Pursuant to CEQA Guidelines (California Code of Regulations, Title 14) Section 15168, the impacts associated with the proposed project were studied, and mitigation measures concerning such impacts were developed, in the Cannabis Program EIR.
