**Project Title:** Stream Crossing Installation for Commercial Cannabis Development (Lake or Streambed Alteration Agreement No. 1600-2020-0236-R1)

**Project Location (Trinity):** The project is located off Brady Road on an unnamed tributary to Kellogg Gulch; Section 35, Township 2N, Range 12W, USGS map Hayfork, Mount Diablo Base and Meridian; Assessor's Parcel Number 011-330-047-000; 40°35'013"N, 123°11'20.6"W.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement 1600-2020-0236-R1, pursuant to Fish and Game Code section 1602, to the project Applicant, Yia Chang.

The project is limited to installation of a culvert on a private driveway to allow year-round access to a proposed commercial cannabis development on the western half of the parcel. The location transmits water from a Class III stream across the driveway. The crossing will be a minimum of a 24-inch corrugated metal pipe that is 20-feet long. The inlet and outlet shall be armored with 12" rip-rap to protect from scour.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on December 22, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project **will not** have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
