Project Description: The proposed cultivation project described herein (Project) includes the cultivation of 4,328 square feet (sf) of mature outdoor cannabis located in Trinity County on Assessor's Parcel Number (APN) 009-440-15-00. The applicant is seeking a Small Outdoor Cannabis Cultivation License from the County (CCL-027) and currently holds a Small Outdoor Cannabis Cultivation License from the Department of Cannabis Control (DCC; CCL19-0004492). Existing cultivation activities include 4,328-sf of mature, outdoor cannabis grown in Terraced Areas A-E (Table 1). Water is supplied by an existing, permitted well with a pump, and is stored in three (3) 2,500-gallon water storage tanks and one (1) 1,150-gallon plastic cone bottom water storage tank. Existing cannabis irrigation diversion lines transfer the water from the well to the water tanks. All processing and composting activities are handled by the adjacent project, known as Trinity Alps Farms, Inc. located on APN 009-440-23-00. A more detailed project description can be found in the attached Appendix C Checklist and the following attachments included with the Appendix C Checklist: Biological Report, Archaeological Report, Odor Control Plan, Water Resource Protection Plan, and Engineered Grading Erosion Control Plan. SPECIAL NOTES: The Biologists listed in Section 5.0 of the Appendix C Checklist, Mike Dean and Jacob Ewald, arethe Biologists that prepared the Biological Report included as Attachment C. The Biologists' names and qualifications are listed below. Mike Dean, Biologist. Mike, our staff biologist, has a bachelor's degree in Zoology and amaster's degree in Biology, from Humboldt State University (HSU). He brings over 34 years of professional biologist experience working for California Department of Fish and Wildlife, California Department of Health Services, The Nature Conservancy, and numerous special consulting projects including aquatic assessments of several streams inNorthern California. Jacob Ewald, Biologist. Jacob Ewald brings over

six years of biological experience to theteam. Jacob has conducted biological surveys for a variety of taxa, including spotted owls, nesting birds, reptiles, and amphibians. He graduated from UC Davis with a B.S. in WildlifeBiology and is currently wrapping up his M.S. thesis in Botany at Chico State University. Jacob has used his most recent education to move into botanical surveys and uses the fullbreadth of his skills to complete CEQA documentation for client projects.
