Project Description (Proposed actions, location, and/or consequences).

CDCR is proposing the construction and operation of a 50-bed Mental Health Crisis Facility. The site for the proposed facility is within the existing secured perimeter of Facility D at CIM. The new building would encompass up to approximately 69,000 gross square feet. Other proposed project components include a new cyclone fence that would encircle the MHCF, a new secure vehicle access area, improvements to the existing pedestrian pathway between the CIM administration building and the MHCF site to comply with ADA requirements, resurfacing and restriping portions of the existing administration building parking lot to comply with ADA requirements, and installation of a new 360-space parking lot outside of the southern perimeter of Facility D.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

In the 2019 EIR, potentially significant impacts that could be reduced to a less-than-significant level with implementation of proposed mitigation measure were identified for Air Quality, Archaeological, Historical, and Tribal Cultural Resources and Biological Resources. This Draft Partially Revised EIR does not identify any changes to any significance conclusions or mitigation measures identified in the 2019 EIR.

If applicable, describe any of the project's areas of controversy known to the Lead Agency, including issues raised by agencies and the public.

On May 8, 2019, CDCR certified the EIR (2019 EIR) and approved the CIM MHCF Project. These actions were subsequently litigated (City of Chino, Chino Valley Independent Fire District, County of San Bernardino and City of Chino Hills (Petitioners) v. CDCR, San Bernardino County Superior Court Case No. CIVDS1917019.) In February 2021, the Court issued a ruling in favor of the petitioners on three of the ten causes of action in their petition for writ of mandate (Ruling). The topics of the three causes of action that were decided in favor of the petitioners are baseline conditions, alternatives, and traffic. Each of these topics are addressed in the Draft Partially Revised EIR.
