The proposed Project includes separating Alamitos Creek from the lake and restoring its upstream and downstream connectivity; re-contouring the lake bottom and capping it with clean fill; expanding the Park into the existing lake and beach areas; expanding the existing island and constructing a new island; revegetating the area with native vegetation; and developing a flow-through water system to circulate water through the isolated lake by connecting the lake via pipeline to an imported water source and pumping water from the lake via pipeline to the Los Alamitos Percolation Pond for groundwater recharge.
