The County of Santa Barbara referred the OASIS Center project to SBCAG for consistency determination with the Airport Land Use Plan (ALUP) on May 25, 2017. Generally, SBCAG has 60 days from the date of referral to determine the consistency of the proposed project. The County of Santa Barbara and OASIS consented to waive this requirement in order to allow for a public hearing at the Airport Land Use Commission (ALUC) on August 17. On August 17, the SBCAG Board, acting as the ALUC for Santa Barbara County, reviewed the project and determined that the project was consistent with the ALUP.
