**Project Description:** The project consists of a minor Long Range Development Plan (LRDP) Amendment to the 2010 LRDP to redesignate the land use of approximately 3.2 acres on the UC Davis Sacramento Campus.

This Notice of Determination is to advise that the University of California  Lead Agency has approved the above-described project on *August 19, 2020* and has made the following determinations:

1. The Project will not result in environmental effects that were not adequately examined in the UC Davis Sacramento Campus 2010 LRDP EIR.
2.  The May 2020 Parking Structure 4 Addendum to the UC Davis Sacramento Campus 2010 LRDP Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures  from the UC Davis Sacramento Campus 2010 LRDP EIR were made a condition of the approval of the project; no new project-specific mitigation measures are required.
4. The implementation of applicable UC Davis Sacramento Campus 2010 LRDP EIR mitigation measures will be monitored and reported pursuant to the UC Davis Sacramento Campus 2010 LRDP EIR MMRP.
5. The previous statement of overriding considerations in the UC Davis Sacramento Campus 2010 LRDP EIR was reaffirmed for this project.
6. Findings  were made pursuant to the provisions of CEQA.
