Project Description: The permitted activity is the abandonment of 5 existing wells to current California Geologic Energy Management Division (CalGEM) standards.

The approved original project, disclosed in the certified environmental document, the Bolsa Chica Lowlands Restoration Project, consists of the restoration of wetlands and aquatic functions and assessment of contamination at the Bolsa Chica Wetlands and Bolsa Gap.

The document analyzes the total removal of oil extraction activities and discusses the proposed activity of plugging and abandoning oil wells. (ES-3) Removal of oil wells is not part of the restoration but was included in the environmental document because oil well removal would occur during the same time period as the project construction.

Pursuant to the provisions of the California Environmental Quality Act (CEQA), an Environmental Impact Report (EIR) was prepared and certified by the Lead Agency, the California State Lands

Commission, for the Bolsa Chica Lowlands Restoration Project and SCH #2000071068. The EIR was certified on 1/30/2002.

The activity(s) being permitted by CalGEM is within the scope of Bolsa Chica Lowlands Restoration Project EIR.

CalGEM, as the CEQA Responsible Agency, approved permit(s) for CRPC to abandon the wells listed below.
