The Proposed Project includes construction and operation of an approximately 12 megawatt power generation facility that would utilize landfill gas as fuel to generate renewable energy. The proposed approximately 2.2-acre power generation facility would be located on a portion of an approximately 95-acre site owned by Los Angeles County within the City of Glendale's land use and zoning jurisdiction. The Proposed Project would beneficially use the landfill gas and would provide environmental and economic benefits regardless of ultimate capacity of the landfill. The Proposed Project would include the plant facility, natural gas pipeline, water pipeline and two water tanks.
