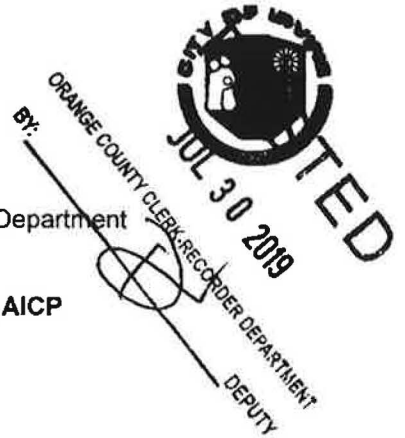

Project Description: A vesting tentative parcel map to subdivide one parcel into four parcels to allow future office development (555,946 square foot office complex within 11 two-story buildings and 4 three-story buildings). Pursuant to Section 15168 of the State CEQA Guidelines, this project is within the scope of the project covered by previously certified Final EIR for the Planning Area 40 / Planning Area 12 General Plan Amendment and Zone Change project. There is no public review period required. The effects of the proposed project were examined in the Final EIR and all feasible mitigation measures and alternatives developed and identified in the Final EIR have been incorporated into the resolution approving the project.



The PA 12 Project site is located southwest of PA 40 and the Santa Ana (I-5) Freeway, northwest of Sand Canyon Avenue, northeast of the OCTA Metrolink rail line, and to the southeast of vacant land.

Project Description: The Project includes development of approximately 3,918 dwelling units; 1,540,000 square feet of Multi-Use; 205,000 square feet of Commercial; and 100,000 square feet of Institutional uses in PA 40 (approximately 571 acres). The Project also includes approximately 575,000 square feet of Research and Industrial (Medical and Science) use on a 36-acre parcel in PA 12. The Project provides for a community park, a public neighborhood park, and several private neighborhood parks. The Project includes an option to convert up to 100 percent of the 1,540,000 square feet of Multi-Use intensity to residential intensity for up to an additional 1,309 dwelling units.

On August 12, 2008, the City of Irvine City Council made all approvals for the Project after the close of the public hearing. The approvals for the Project included a General Plan Amendment and Zone Change to allow for a change in land use in PA 40 and PA 12. The City of Irvine filed a Notice of Determination for all approvals for the Project on August 13, 2008, in compliance with Section 21152 of the Public Resources Code.

To implement the Project, the City Council held a second reading and approved the Zone Change ordinance as part of its consent calendar on September 9, 2008. The City of Irvine is filing this current Notice of Determination to document that the City Council held the second reading and approved the Zone Change ordinance to implement the Project.
