NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL IMPACT REPORT (EIR)

The City of Gilroy has prepared a Draft EIR for consideration by the public, as follows:

Project Title: Gilroy 2040 General Plan

Application No.: General Plan Amendment GPA 13-02.

Project Location: City of Gilroy (Citywide), Santa Clara County

Lead Agency: City of Gilroy **Division:** Community Development (Planning)

Project Description: The Gilroy 2040 General Plan is an update to the Gilroy 2020 General Plan, adopted in 2002. The Gilroy 2040 General Plan will benefit residents, businesses, developers, and decision makers.

Significant Environmental Effects: The EIR identifies the following significant environmental effects that would result from the proposed project: **Air Quality** (Inconsistent with the Clean Air Plan, Increase in Operational Criteria Air Pollutant Emissions Resulting from an Increase in Vehicle Miles Traveled Will Degrade Air Quality, Adverse Effects to Sensitive Receptors from Toxic Air Contaminants), **Biological Resources** (Adverse Effect on Special-Status Plant and Wildlife Species and Protected Nesting Birds, Adverse Effect on Jurisdictional Wetlands and Waterways), **Cultural Resources** (Adverse Change in the Significance of a Historic Resource, Adverse Change in the Significance of a Unique Archaeological Resource, Disturb Native American Human Remains), **Greenhouse Gas Emissions** (Generate a Volume of GHG Emissions in 2040 That May Have a Significant Impact on Climate Change; Conflict with an Applicable Plan, Policy, or Regulation Adopted for the Purpose of Reducing GHG Emissions), **Transportation and Mobility** (Increase in Vehicle Miles Traveled).

As enumerated under Section 65962.5 of the California Government Code, sites listed as hazardous waste facilities, hazardous waste properties, and/or hazardous waste/disposal sites exist within the City.
