Project Description: UC San Diego proposes to construct the Viterbi Family Vision Research Center. The new facility would provide space for research on various ophthalmologic diseases and expand interdisciplinary collaborations across campus and the San Diego community to accelerate the discovery and innovation of vision research. The project site is in the Health Sciences East Neighborhood of the La Jolla Campus, within the existing academic-medical complex. The proposed project would comprise approximately 100,000 gross square feet and approximately 60,000 assignable square feet.

This Notice of Determination is to advise that the University of California Lead Agency has approved the above-described project on November 17, 2022 and has made the following determinations:

1. The Project would not cause any significant environmental impacts nor an increase in the severity of significant impacts previously studied in the UC San Diego Long Range Development Plan (2018 LRDP) Environmental Impact Report (EIR).
2. Addendum #10 to the UC San Diego 2018 Long Range Development Plan (LRDP) Environmental Impact Report was prepared for this project pursuant to the provisions of CEQA.
3. Relevant mitigation measures from the 2018 LRDP EIR were made a condition of the approval of the project; no new project-specific mitigation measures are required.
4. The implementation of applicable UC San Diego 2018 LRDP EIR mitigation measures will be monitored and reported pursuant to the 2018 LRDP EIR’s Mitigation Monitoring and Reporting Program.
5. Findings were made pursuant to the provisions of CEQA.
