Project Description: UC Davis proposes a license agreement with the Oakland Ballers Baseball Club for use of the Dobbins Baseball Stadium (Stadium) for professional minor league baseball games. The license agreement would grant use of the Stadium by the Oakland Ballers Baseball Club for approximately 52 games per year and additional practice sessions from May through September of each year, starting May 2024. The agreement will be in place until September 2028, with an option for an additional 5 years. The agreement stipulates that UC Davis provide physical improvements to the Stadium to allow for night games, which include new field lighting and a new video scoreboard. The capital improvements to the Stadium are proposed to be approved separately and were analyzed in the March 2024 Addendum.

This Notice of Determination is to advise that the University of California \square Lead Agency has approved the above-described project on $\underline{May 13}^{th}$, $\underline{2024}$ and has made the following determinations:

- UC Davis 2018 LRDP EIR sufficiently analyzes and addresses potential environmental impacts from
 the project, and the project will not trigger any of the criteria requiring additional CEQA review
 pursuant to CEQA Guidelines Section 15162. The project will not result in new significant impacts or
 a substantial increase in the severity of the environmental impacts identified in the UC Davis 2018

- 4. The implementation of applicable 2018 LRDP Final EIR mitigation measures will be monitored and reported pursuant to the 2018 LRDP Final EIR's MMRP.
- 5. The previous statement of overriding considerations in the 2018 LRDP Final EIR was reaffirmed for this project.
