This Addendum to the Environmental Impact Report (EIR) certified in 2017 for the City of Palo Alto 2030 Comprehensive Plan analyzes the impacts associated with the proposed Sustainability and Climate Action Plan ("proposed project" or "S/CAP"). The proposed project consists of an update of the Sustainability and Climate Action Plan with revised greenhouse gas reduction targets and strategies. In accordance with CEQA, the EIR Addendum demonstrates, based on substantial evidence, that the prior environmental analysis in the 2017 EIR adequately addresses the potential environmental effects of the project, and the project does not require subsequent environmental review pursuant to CEQA Guidelines Section 15162 and 15164, and supports the City's finding that the project would not result in significant new issues nor exceed the level of impacts identified in the previously certified 2017 EIR requiring additional analysis under CEQA.


