The Burbank to Los Angeles Section Draft EIR/EIS public review period will now end on July 31, 2020.

The California High-Speed Rail Authority (Authority) is notifying you that the public review period for the Burbank to Los Angeles Draft Environmental Impact Report/Environmental Impact Statement (EIR/EIS) has been extended to now end on July 31, 2020.

The Draft EIR/EIS was originally made available for a minimum 45-day public review beginning on May 29, 2020 and ending on July 16, 2020, pursuant to the California Environmental Quality Act and National Environmental Policy Act. The Authority has decided to extend the comment period so that it will now end on July 31, 2020, in response to agency and stakeholder requests in consideration of limitations caused by the novel coronavirus pandemic. **The comment period is now May 29, 2020 to and including July 31, 2020.** Comments must be received electronically or postmarked on or before July 31, 2020.
