The California Department of Transportation (Caltrans), in cooperation with the City of Long Beach, has completed the Draft Environmental Impact Report/Environmental Assessment (EIR/EA) for the Shoemaker Bridge Replacement Project. The proposed project is located at the southern end of the State Route 710 corridor and leads to the City of Long Beach. The project would reconstruct Shoemaker Bridge and realign local street connections in the area. The Project is needed to improve safety, operations, and connectivity between downtown Long Beach and regional transportation facilities.
