ENVIRONMENTAL IMPACT REPORT AND PUBLIC COMMENT PERIOD FOR THE PROPOSED SUNNYVALE WATER POLLUTION

**CONTROL PLANT (WPCP) MASTER PLAN** 

**Project Description.** In the 2016 Program Environmental Impact Report (PEIR) for the Sunnyvale Water Pollution Control Plant (WPCP) Master Plan (Master Plan), the City proposed to approve the *Sunnyvale Water Pollution Control Plant Master Plan* for the Donald M. Somers Water Pollution Control Plant. The approved Master Plan serves as a long-term guide for upgrading and replacing the WPCP's facilities and operations to ensure that the WPCP can meet changing regulations, treat existing and projected wastewater flows reliably and cost-effectively, and increase recycled water production.

Following certification of the Master Plan PEIR and approval of the Master Plan, the City proceeded with design of the Sunnyvale WPCP Secondary Treatment and Dewatering Facilities Project (the Project). This Addendum to the PEIR provides project-level environmental review of the Project. The project will augment the City's current secondary treatment process with conventional activated sludge facilities and construct a thickening and dewatering facility and support facilities.

**Project Location.** The Master Plan would be implemented at and near the Sunnyvale WPCP, 1444 Borregas Avenue, Sunnyvale CA.

**Environmental Effects.** The proposed project will have potentially significant environmental effects regarding Transportation, Air Quality, Biological Resources, Hazards and Hazardous Materials, and Cultural Resources. The California Environmental Quality Act (CEQA) requires this notice to disclose whether any listed toxic sites are present at the project location pursuant to 14 Cal Code Regs § 15087(c)(6). The following two facilities were identified within the Master Plan area adjacent to Carl Road:

- City of Sunnyvale, BOP/Recycling Center, 164 Carl Road
- City of Sunnyvale Landfill, South of 164 Carl Road.

**Public Review.** The 30-day public review period for this addendum to the PEIR begins on 3/28/2022 and ends on 4/26/2022. Written comments must be received at the Public Works Department, or via email at <a href="mailto:pubworks@sunnyvale.ca.gov">pubworks@sunnyvale.ca.gov</a>, by **4:00 p.m.** on 4/26/2022 to be addressed as part of the formal PEIR Addendum review process.
