Project Location: The Project is located at 5655 West End Road in Arcata City on APN 507-382-001-000.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Processor cannabis license submitted on 10/2/2019 by Humboldt Partner Group, Inc.

Project Activities:

The Project will consist of cultivation, processing, manufacturing, and distribution of medical cannabis at a new 10,000 SF building proposed to be constructed on the property. A design review permit is approved for new construction and site improvements that include a 10,000 SF building, an accessory structure for a generator, vehicle, and parking, paving, landscaping, solid waste and recycling, security and lighting. The property is zoned Industrial General and located in Area 2 of the Medical Marijuana Innovation Zone.

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption project. Class 32 Categorical Exemptions consists of projects characterized as in-fill development meeting the conditions described in this section. (a) The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations. (b) The proposed development occurs within city limits on a project site of no more than five acres substantially surrounded by urban uses. (c) The project site has no value as habitat for endangered, rare or threatened species. (d) Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality. (e) The site can be adequately served by all required utilities and public services.
