Project Title: City of Berkeley Tuolumne Camp (Streambed Alteration Agreement No. 1600-2018-0103-R4)

Project Location: The Project will occur at the City of Berkeley Tuolumne Camp at 331585 Hardin Flat Road, South of State Route 120, in Groveland, Tuolumne County, California, Section 31, Township 1 South, Range 19 East, USGS 7.5 Minute Quad Map Ascension Mountain, MDB & M, Latitude 37°48'42.6"N, Longitude 119°55'49.8"W.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2018-0103-R4, pursuant to section 1602 of the Fish and Game Code to the project Applicant, the City of Berkeley, Parks, Recreation, and Waterfront Department.

The Project includes activities related to the demolition of remnant concrete foundations and facilities, installation of a raw water pump station, pedestrian bridge over the South Fork of the Tuolumne River, and accessible path of travel, the relocation of an intermittent drainage, replacement of headwall of an intermittent drainage, and the riparian revegetation of the camp.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 1/23/2020 and has made the following determinations regarding the project:

1. The project will not have a significant effect on the environment.
2. A mitigated negative declaration was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
