This project will implement fuelbreak and wildfire fuel reduction treatments on 165 acres of forestland. Treatment activities include prescribed (pile & broadcast) burning, mechanical/manual treatments, herbicide application and prescribed herbivory. Gold Ridge Fire Protection District is undertaking the Project in the context of the California Vegetation Treatment Program (CalVTP) Program Environmental Impact Report (Program EIR), which the Board of Forestry and Fire Protection certified in December 2019 (SCH No. 2019012052). The Program EIR evaluates the potential environmental effects of implementing qualifying vegetation treatments to reduce the risk of wildfire throughout the State Responsibility Area in California. It was designed for use by many state, special district, and local agencies to accelerate vegetation treatment-project approvals by finding them to be within the scope of the Program EIR. Gold Ridge Fire Protection District prepared a Project Specific Analysis and determined the activity is within the scope of the CalVTP Program EIR.
