The project totals 241 footprint acres utilizing mechanical treatment, manual treatment and prescribed herbivory and primary treatment and prescribed (pile) burning and herbicide application as follow up treatments. The project also includes Right of Way Clearing (fuelbreak) along Glencannon, Green Valley, Rockville, Twin Sisters, and Valley End roads covering 6.9 total road miles. Clearing will include areas within the County Road Easement.
