Project Title: Lathrop Wye and Track Extension Project (Streambed Alteration Agreement EPIMS Notification No. SJN-25436- R2)

Project Location: The project is located at the French Camp Outlet Canal in the City of Manteca, in the County of San Joaquin, State of California; Latitude 37.81805, Longitude -121.26214. Assessor's Parcel Number 198-011-070-000. The project is generally located approximately 0.45 miles northwest of the intersection of Villa Ticino Drive and W Louise Avenue.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification No. SJN-25436-R2, pursuant to Section 1602 of the Fish and Game Code to the project Applicant, the San Joaquin Regional Rail Commission as represented by Brian Schmidt.

The project is limited to the construction of a double barrel reinforced concrete box culvert in the French Camp Outlet Canal. The culvert structure will consist of a cast-in-place concrete box culvert structure within an earthen, man-made portion of the canal. The double-barrel concrete box culvert will be approximately 384 feet long, 30 feet wide, and 11 feet tall. Two concrete wing walls will be installed on each end of the culvert, each measuring approximately 20-feet long and 11-feet tall. Approximately 100 cubic yards of riprap will be placed at a depth of 5.5-feet around each end of the culvert. It is anticipated that all earthwork will be conducted using equipment staged on the bank.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the environmental impact report prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
